Motion by Board Member VerBerkmoes with support from Board Member Orent to approve the meeting minutes and informational meeting minutes of January 14, 2025. Motion carries unanimously.

Public Hearings & Special Guests

David Eberle of Bloom Sluggett, PLC gave a presentation on what a DDA is, the revenue sources, expenditures and compliance laws. Presentation slides are included with the minutes.

Petitions & Communications

7. A. Three items were presented to the board for proposed budget items for the 2025-2026 fiscal year. Board member DuPilka stated that he was on board for the proposed items but would like to see the numbers first. Board Member Gerard stated that he was for the Merlin Enclosure and City Hall remodel but not really in favor of the Building Improvement Grant. Staff gave a brief update on the current Building Improvement projects. Coopersville Hardware is almost completed and waiting on updates from Courtade Body Shop and Fatzos. Board Member DuPilka recommended \$20,000 for the Building Improvement plan and the board agreed.

7. B. – A Contract was presented from McKenna totaling \$14,500 for the TIF and Development update. Discussion followed clarifying what the City Council had voted for the Master Plan and City Ordinances and the grant covering the costs of those. The DDA will need to amend the budget to cover the full \$14,500 for the proposed plan. Board Member DuPilka motioned to approve the amendment to the budget to hire McKenna for the

proposed TIF and Development Update. Board Member Gerard supported the motion. Motion carries unanimously.

7. C. Staff recommended approving a one year extension with Bob's Asphalt for the Snowplowing Contract with the boards approval. Board Member VerberkMoes motioned to approve the extension. Board Member Orent supported the motion. Motion Carries unanimously.

Motion by Board Member Gerard with support by Board Member Merkins to receive and file the DDA Information Packet. Motion carried unanimously.
